# Annual Meeting of the Congregation January 29, 2023

President Jerry Moses called the January 29, 2023 congregational meeting to order at 9:01 a.m. in the sanctuary of Grace Lutheran Church with 46 congregants in attendance (3 of the individuals joining via Zoom).

#### 1. Opening Devotions

Interim Pastor Mark Bogen led the members present in a responsive Opening Litany for Congregational Annual Meeting to focus our thoughts and discussion.

#### 2. Congregational Meeting Minutes from January 30, 2022

Les Widmer moved to accept the congregational meeting minutes from January 30, 2022. Sarah Auen seconded. Vote was taken. Motion carried.

#### 3. Reports

Janet Dorr moved to accept the combined pastoral staff reports included in the annual report document. Ed Muffler seconded. Vote was taken. Motion carried.

Mary Nossaman moved to accept the combined reports of the Church Council. John Avers seconded. Vote was taken. Motion carried.

Beth Muffler moved to accept the combined auxiliary services reports included in the Annual Report. Pam Pelphrey seconded. Vote was taken. Motion carried.

Richard Bauer moved to accept the Endowment Report. Pam Pelphrey seconded. Vote was taken. Motion carried.

#### **4. Financial Reports**

The combined Noah's Ark Preschool and overall Grace Lutheran Church budgets were addressed next. President Jerry Moses invited questions and discussion concerning both proposed budgets.

Harry Anspacher directed members' attention to page 42 of the Annual Report, inquiring whether or not the \$99,000 designated for a pastoral salary and benefits package is an appropriate amount. Ed Muffler, as a member of the Call Committee, shared that the Synod provides estimates according to a required salary table based on years of experience, and the projected amount aligns with the lower end of the 5-10 years' experience salary range.

Harry then asked about the deficit realized in the actual expenses (\$53,000) at the end of 2022. The next year's projected deficit is \$23,000 (end-of-year 2023 projection). Specifically, he wanted to know if the deficits are cumulative... thus in 2 years would the amounts indeed result in an incremental deficit (\$76,000). Additionally, he added that he'd like to know how that deficit will be remedied. Jerry explained that yes, the amounts would be cumulative, however the hope is that funding from the back page accounts would now be adjusted and moved in order to cover the 2022 annual deficit, now that the 2022 income and expense figures are finalized. Over the next year, the hope is that giving will increase to offset the projected 2023 annual deficit.

Larry McElfresh and Jim Scranton requested clarification concerning the General Fund difference between the 2021 and 2022 Balances (page 37). Jerry explained that a one million undesignated gift was received thanks to a gracious bequest. The individual involved wished to remain anonymous, and because there were administrative details that needed to be worked out behind the scenes (receipt and processing), the amount could not be posted to the 2022 Balance until the last minute. The Council Executive Team plans to meet in February to make decisions on how to apply the funding in accordance with the wishes of the estate.

Ballots were distributed and counted. Motion carried.

#### 5. Resolutions

Resolution #1: Church Budget

Richard Bauer moved to accept the resolution. Pam Pelphrey seconded. Vote was taken. Motion carried.

Resolution #2: Church Volunteers

John Avers moved to accept the resolution. Jan Harris seconded. Vote was taken. Motion carried.

Resolution #3: Church Staff

Connie Amor moved to accept. Les Widmer seconded. Vote was taken. Motion carried.

Following the official motion, Harry Anspacher invited the congregation to join him in a round of applause to celebrate our hardworking church staff!

#### 6. L.I.F.T. Re-Approval

The L.I.F.T. Operation Agreement was shared in the Annual Report document. President Jerry Moses invited questions and discussion concerning the information contained therein.

Harry Asnpacher, although he admittedly has not attended a L.I.F.T. event lately, pointed out that Lay Associate Minister Maureen Pump's activities as a full-time pastor appears extremely numerous compared to the activities shared and listed in Pastor Paul Bailie's report. Reviewing this, it seems possible that if, the full-time pastors all chipped in a little bit, that the church-connected pastors could cover these activities and replace the need for the L.I.F.T. pastor. This would greatly reduce costs and the need to support a separate L.I.F.T. operation. Harry also proposed that the congregations could chip in order to support a pastor that could shepherd and preach St. Mark's instead of supporting St. Mark's through the L.I.F.T. organization.

Interim Pastor Bogen shared thoughts as "an outsider." He believes L.I.F.T. is a very good collaborative operation, along with being a financial challenge. Trinity, following their closure, contributed financial support in 2022, but were not able to continue support in 2023. Grace Lutheran's contribution has been reduced by \$13,000 for 2023 compared to 2022, thus ability to support has been adjusted, and those funds are redirected internally. L.I.F.T. also experienced a savings during the salary gap between Pastor Scott and Pastor Paul.

Larry McElfresh offered that endowment funding has been used to support our contribution to the L.I.F.T. operation over the past few years.

Pastor Bogen added that the hope is that additional congregations will join forces to support L.I.F.T. financially in the future.

Richard Bauer requested access to the detailed L.I.F.T. financial statements in order to better understand how funding is assigned and distributed to events and various expenses. Linda Baumer shared that the financial statements can be made available at the Church Office within a month's time.

Pastor Bogen provided a general description of the \$124,000 budget designation: the L.I.F.T. called pastor, Bridge of Hope, and several part-time administrative positions. He also reminded the congregation that, to date, no collected offerings have been directed to the financial support of the operation.

Al Mehlow clarified that the Endowment funding is restricted to outreach functions. Due to recent market downturn, the Endowment funding available in the next few years may be limited. The available funds are based on a 3–4-year market average. The amount available next year is yet unknown.

Jerry Moses noted that it does not seem fair to "pull the rug out from under" the L.I.F.T. operation at this point, but the membership's desire for increased accountability is also fair. Cindy Scranton requested clarification, that the vote was to continue the agreement despite the questions and need for more details in the future.

Nelda Bauer moved to approve the L.I.F.T. Operation Agreement for 2023. Janet Dorr seconded. Vote was taken. Motion carried.

Kristen Lindsay respectfully recommended that the L.I.F.T. accountability discussion be addressed at the next Council meeting in a few weeks, to provide time for questions to be submitted and the receipt of feedback in a timely fashion.

#### 7. Amendment to Constitution / Bylaws

Jerry Moses explained that the change concerning the Financial Secretary and Assistant Financial Secretary position adjustments (elimination from the list of officers outlined in the Constitution and Bylaws) is alignment to current practice. As the size of Council has been downsized over the past few years, and the difficulty of identifying multiple individuals amongst the Council members with financial talents rose, it was necessary to redirect efforts and identify non-Council members to fill these positions. This change provides for greater flexibility in carrying out financial secretary responsibilities.

Al Mehlow moved to accept the amendment. Janet Dorr seconded.

John Avers pointed out that, as listed in Chapter 12 (although not on the table for an adjustment at this time), the pastor should not possess voting membership on Council. As in line with other church operations that he is aware of, the pastor should be an exofficio member only.

Linda Baumer interjected that the change cannot be made at this meeting due to the Constitutional requirement that the membership be presented with projected changes for a standard review period prior to voting to amend. The constitution requires prior notification.

Pastor Bogen offered a point of information, clarifying that the initial amendment was proposed at a previous congregational meeting, thus if this change were proposed it would need to follow the same procedure and be voted on at the next congregational meeting. The proposed changes in the Annual Report reflect items that were introduced at a previous congregational meeting.

John Avers moved to table the motion on the floor. Richard Bauer seconded. Point of information was provided and the members were reminded that a motion to table is not debatable.

Jerry Moses reminded the members present that Ruthann House could exit the Treasurer position with no other option than to appoint from a pool of current Council members, despite the fact that other members outside of Council may have greater financial acuity.

Harry Aspacher inquired after who completes the worship accounting, typically completed by the Financial Secretary? Linda Baumer shared that it is redistributed to an accounting team approved by Council who receives and tabulates weekly giving.

John Burmeister asked whether or not the Interim Pastor was considered full-time, and thus is granted all rights due a regular full-time pastor. It was clarified that interim, even though temporary, equates to full-time.

Les Widmer asked if the vote could be completed on part of the amendment, and not all of the amendment, to ease the work of the Council concerning the financial duties.

The amendment was presented as a package, and the motion includes the entire entry included in the Annual report. It cannot now be teased apart.

Vote to table the motion was taken. Motion carried. The amendment adjustment is tabled. Council members will need to consult constitutional requirements concerning reintroduction.

#### 8. Elections

Jerry Moses shared that Lori Wise and Matt Moss are both interested in re-election to the Endowment Board. Harry Anspacher moved to elect both candidates. Jan Harris seconded. Vote was taken. Motion carried.

#### 9. Adjournment

Richard Bauer moved to adjourn with prayer. Harry Anspacher seconded. Vote was taken. Motion carried. Pastor Bogen then shared a closing prayer.

## **Interim Pastor**

Dear Friends in Christ,

Annual Meeting time is a good time to reflect on the year that has passed. 2023 was a busy year at Grace and LIFT, so allow me to do a quick summary by month:

January Heather and I accompanied LIFT confirmation youth on a weekend retreat to Hopewood Pines (formerly LMC, Lutheran Memorial Camp. Youth loved it, and we'll do something similar again this year. The Endowment Fund reported an ending value of \$1,175, 971, representing a loss of \$179,310 over the previous year. Linda, John Avers and I began monthly meetings to update the Grace Constitution.

February We continued our work to complete the Congregation Photo directory that we began last October with portraits taken by Dave Casperson. We used an online service called Instant Church Directory to upload photos and contact info to create an online directory. "Amazing Grace" was the theme for our 2023 Lenten midweek worship series.

March The Constitution Task Force continued its work. The congregation picture directory was published online. Grace hosted The Fisk Jubilee Singers, an historic black gospel choir from Fisk University in Nashville. This choir first performed in Fremont in 1882 when they sang for President Rutherford B. Hayes at his Spiegel Grove Home.

April A group of nine mostly 2nd grade boys and girls learned about Holy Communion and received for the first time on Palm Sunday. The Good Friday Fish Fry returned in support of the Soup Kitchen. 279 attended Easter worship.

May Becky Seibert joined a group from NW Ohio Synod to travel to Tanzania for installation of the new bishop of the Dodoma Diocese of the Evangelical Lutheran Church in Tanzania, one of our companion synods. This was Becky's 12th trip to Tanzania.

June Grace moved to holding one service on Sunday morning at 9:00 am. Council approved a campaign to purchase new Evangelical Lutheran Worship hymnals. Heather spearheaded the third season of LIFT Park Tour. The Constitution Committee continued its work. A new summer musical activity was held for LIFT kids, Hearts and Hands and Voices Academy, held June 26-29. A LIFT group spent a Saturday packing food for the Children's Hunger Alliance food. The Chalfins and the Ohms families were received as new members, and Council members were installed.

July For the first time in a long time, Grace sent kids to camp (Hopewood Outdoors, aka LMC), a total of four. LIFT VBS was held at St. Mark with the theme God's Good Creation. LIFT Outdoor Worship was held at Birchard Park. Bathroom renovation was approved by Council, and the LIFT Park tour continued.

August A new LED Sign in the parking lot was installed and became operational. Heather led an informational meeting regarding the 2024 Youth Gathering, scheduled for July 16-20 in New Orleans. A group of about a dozen LIFT youth and adults will register for this faith-building event.

September For the first time, LIFT congregations participated in the ELCA-wide service day, God's Work Our Hands. After a tasty lunch at St. Mark, LIFT members participated in four service projects around the community, including mulching and weeding at Birchard Place homeless shelter, Clothes sorting at Alicia's Closet, card and letter writing for shut-ins, including prisoners, and food packing at Bridge of Hope, LIFT's food pantry. LIFT was blessed by a multi-week visit from Jana Jaroslav Marek from the Slovak Evangelical Church of the Augsburg Confession in Serbia, another of our synod's companion synods.

October Fall Fest moved indoors because of the weather, but still a successful event that invited community participation. After the brutal attack by Hamas on October 7, Spirit Bible Study group spent some weeks learning about the history of modern Israel and the never-ending conflict between Israel and Palestinians. We launched our 2023 Stewardship Appeal with the theme "Blessed to Be a Blessing."

November "With Gratitude & Remembrance" was the theme for the 2023 Annual LIFT sponsored Choral Festival - Great Hymns of Faith. November 12 was our Stewardship Ingathering. To date, we have received 81 intents for giving in 2024 (same as last year) totaling \$236,184, a slight increase over last year. Projecting giving in 2024 is estimated at \$390, 884. We bid farewell to Tom with thanksgiving for his excellent musicianship on the organ and piano, and leadership in all things music at Grace over the past four years.

December New men's and women's restrooms at the back of the sanctuary were completed in time for the Toledo Symphony on December 1, a sold-out event. New cranberry colored Evangelical Lutheran Worship hymnals were installed and dedicated. Midweek Advent worship was a LIFT event. "The glory of the Lord shall be revealed" was our theme, inspired by Isaiah 40:5. Worship attendance at two Christmas Eve Services totaled 223. Worship on December 30-31 was LIFT sponsored, Saturday at Grace and Sunday at Emmanuel.

As you can see, 2023 was a fruitful year. There is so much ministry that happens every day and every week at Grace and through LIFT that is not reflected in this summary, carried out by excellent staff and dedicated volunteer members. All a strong reminder that God has been good, all of the time. All of the time, God has been good.

I have indicated to Grace leadership and to the congregation in my January pastor's message in Grace & Truth that I will join Marcy in retirement in early May. In that message I also included some pastoral thoughts, which you can read in your hard copy, or at <a href="https://bit.ly/47Vi1GH">https://bit.ly/47Vi1GH</a>

Allow me to close this message with words of appreciation for everything that you do as a congregation. I have very much enjoyed my service at Grace these past months.

## L.I.F.T. Pastor

LIFT (Living in Faith Together) is a unique collaboration of congregations working together in the Fremont area. Our full member congregations are Emmanuel, Grace, St. mark, and St. John's. Faith and Hayes memorial are associate members. Camino de Vida is a developing worshipping community. LIFT is primarily sustained by contributions from member congregations. Pastoral leaders from the congregations gather monthly for collaboration and collegiality. LIFT's five mission priorities are: **Present in our community, Witnessing to God's love, Hearing the needs, Serving our neighbor, and Striving for justice.** 

LIFT's partnership with Lutz Elementary is up and running for a second year. This is an exciting chance to partner in the community and meet some real hunger needs—filling gaps for kids to eat on the weekends when there is no school lunch program. We send a backpack home on weekends with some healthy snacks and food that kids can prepare on their own. School staff identifies students with food insecurity issues at home. An active team of volunteers organizes food donations and assembles the backpacks, and delivers them to Lutz. We are serving 45 families, for a total of 107 children. This is a 161% increase from last year! We are very grateful for the donations that help support this weekend food program.

(LIFT Pastor continued.)

Bridge of Hope (Puente de Esperanza) is a LIFT ministry that operates a food pantry housed at Hayes Memorial United Methodist as well as offering outreach and support to local migrant worker communities. Over 200 welcome baskets for migrants were assembled and distributed. A community garden at Hayes complements and supplements food pantry donations. Bridge of Hope and Camino de Vida hosted two outreach events for the Hispanic community this holiday season: The Thanksgiving Feast and The Christmas Posada. LIFT congregations donated turkeys and toys, respectively, for these events. We give thanks for the work of outgoing coordinator Annie Garcia.

Worship is LIFT's primary way of proclaiming God's love. As LIFT Pastor, I am usually at St. Mark on Sunday mornings. In September, following the retirement of Pastor Dennis Wansitler, I began preaching at Emmanuel each week. In August, I covered preaching at Camino de Vida for several weeks. We gathered as a LIFT parish several times this year:

LIFT Lessons and Carols

In both Lent and Advent, I compiled devotional resources including reflections from members of LIFT congregations.

Students and leaders from Grace and St. John's gathered to learn key aspects of the Christian faith. I collaborated to teach confirmation during the 2022-2023 school year.

LIFT hosted the Easter Extravaganza on April at Grace. This was an event for families with kids preK-5 with games, crafts, and activities to help learn more about Easter. It included an egg hunt and an Easter photo backdrop.

After Easter, I led a six week study on faith and civic life on Wednesdays at Grace, using a resource from the ELCA.

During the summer, leaders from LIFT congregations gathered in local Fremont parks on Wednesday evenings as a way of being present in the community.

LIFT hosted two summer opportunities for children in our community to learn together. The Hearts, Hands, and Voices Arts Academy was held at Grace in June. Participants made music with choir, bells, recorders, and rhythm. LIFT VBS was held at St. Mark on July 10-13. Over 40 children learned about God's Good Creation. Our LIFT VBS offering was able to purchase two chicks, two pigs, two sets of honeybees, and a goat for families around the world through ELCA Good Gifts!

On September 10, LIFT marked God's Work Our Hands Sunday with a meal at St. Marks and a variety of service projects around Fremont:

Mulching and weeding at Birchard Place (FKA Community Fortress)

Clothes sorting at Alicia's Closet, a resource for foster families, housed at St. John's

A project with LIFT's Bridge of Hope pantry

Card and letter writing for shut-ins, advocacy, and the incarcerated

On Wednesdays starting September 13, LIFT offered a time for toddlers and their parents at 5:45 PM at Grace. Heather Hawn and I lead activities geared toward developing spiritual formation for this age group. This is one element of Grace's Spirit activities on Wednesday evenings.

LIFT hosted the Great Hymns of Faith Choral Event on November 5, 2023 at 4:00 PM at Grace Lutheran Church. Noted musical director Michael Shirtz conducted the assembled choir. Presented the week before Veteran's Day, the theme was "With Gratitude and Remembrance."

Before the pandemic, LIFT would send teams out to a local laundromat to be present in the community and pay for people's washing. The ministry continued several times this year, primarily with leaders from St. Mark.

LIFT has a Mercy Fund, which is available to help provide assistance to individuals in crisis situations.

LIFT also serves as the Fiscal Agent for Project LifeSaver a public safety program designed to protect and locate missing persons due to wandering.

#### CASH MANAGEMENT ACCOUNT (CMA) UPDATE (Fund established to hold Memorials & Bequests)

As a follow up to our November 2023 request in the bulletin and newsletter for input/ideas on the potential use of these funds, we received three formal responses as follows:

- 1) The Endowment Committee unanimously requested that 25% of the bequest be directed to the Endowment Fund.
- 2) Move forward with the air conditioning project in the church.
- 3) Invest in the ELCA Foundation's Ministry Growth Fund.

The Executive Committee and Council have not taken any action on the above three items at this point in time.

We did approve a \$2,000 gift from the CMA account to the ELCA Synod in support of their Micro Grant Initiative, whereby ELCA congregations can request a grant to start a new project in their respective community.

In addition, the finish work on the significant restroom renovations/additions continues.

Finally, the Executive Committee discussed the desire to continue to build our youth program.

Our most recent financial report for the CMA account (12/31/23) shows a balance of \$1,388.956. We project annual interest earnings to be approximately \$65,000 on this fund as it currently stands.

We strive to carry the message of Grace Lutheran Church to our community, locally, and globally to represent our congregation in doing the will of our Lord Jesus Christ and to love our brothers and sisters in our church, community, nation, and the world.

**We Support** the following through direct assistance or dedicated Yellow Mission envelope offerings: Liberty Center, My Brother's Keeper (our Member to Member Ministry) which provided assistance for 7 people in 2023, Soup Kitchen, and Sandusky County Food Pantry. We support National and World Missions through Lutheran World Relief, ELCA World Hunger, and ELCA Global Missions.

We as a congregation join in financial support for ELCA Missionary Rev. David Brondos who is serving in Mexico City. Our budget includes \$1800 for his support. We also provide support for NW Ohio Synod, Global Mission Water Project of Mzagole, Tanzania, East Africa.

**Programs** - Bridge of Hope Ministry and Grace Bookworms reading group continue to meet. We have continued using our shopping carts located in the Narthex to continue the collection of food donations for our monthly Food Pantry Challenge. We continue collecting for the monthly Noisy Offering. Collections for the year 2023 were donated to the Soup Kitchen, Backpack Buddies, Liberty Center, and Noah's Ark Preschool.

**Events of 2023** of our committee included a Valentine's Day Party in February which included food and games for our church community also including the children and families from Noah's Ark. An outside clean-up was made at the Liberty Center by members of our committee. We assisted with the welcoming of a family into a home built by Habitat for Humanity by helping with the final cleaning and gifting them a basket of cleaning essentials. In June, we helped pack food boxes for Children's Hunger Network. In September, we handed out bottled water and bags of popcorn (donated by Rural King) in front of the church during Fremont's Cruise-In Car Show. The month of October, we organized the Fall Fest which included our Soup Cook-Off, activities for the youth, a costume contest, and a car show in the west parking lot. A funeral planning event was led by Maureen to assist members in making arrangements for their funeral. In December, the women of the church enjoyed the Women's Christmas Brunch with an exchange of Christmas ornaments, a light lunch, and a Christmas Carol sing-along.

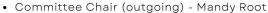

## Altar Guild 2023

The Altar Guild is a ministry of "quiet service." It is behind the scenes, but a most critical act of service to the church. Altar Guild members are servants of God's people as well as servants of God.

The Altar Guild's tasks have a profound impact on the life of the church. The beauty of altar guild work has true theological value. It says something about how we care for what we do as well as how we care for people. It tells us that every detail has significance, and every task is important.

During the past year, the candelabra oil filled candles have been replaced with battery operated candles. The reasoning for this change is multifold. Lighting the oil filled candles was a challenge for many acolytes or even an adult. Filling the oil candles was a challenge as well. Secondly this procedure could be considered a fire hazard. Also, the cost of oil has increased over the years. New battery-operated candles now fill the candelabras and are quite handsome. We will be using rechargeable batteries to defray the cost of replacement batteries.

The Altar Guild is responsible for tasks such as: Preparing the altar per the Church calendar year, Setting the table with the elements (bread and wine) to be administered during communion, Laundering and ironing altar and worship linens, polishing brass and silver, ensuring that all candles are in good operating order. Cleaning up after services and either preparing for another service or "closing down" for the day.

Pre-prepared individual wine/wafer sealed cups continue to be offered for those who wish to commune in the pew and for those attending car church.

We thank the men and women who have served this past year. We praise God with our service and invite all who are willing to serve the Lord in this capacity. There are many ways to serve. Some of which are preparing communion, changing the paraments as the church calendar dictates and keeping the candles in good working order. You are welcome to be a part of this quiet way of service. Service on altar guild is flexible to your schedule, serving either in preparation or conclusion of worship. You will be paired with an existing member and work in teams. This is a great opportunity to work with your son or daughter and a wonderful family experience in service. #### **Operating Agreement**

## Approved by all Full Member Congregations and in force as of 2/2020

**Fundamental Charitable Purpose**. Notwithstanding anything herein to the contrary, the organization is organized exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. All provisions herein shall be subject to such purpose.

#### 1) Definitions

- a) "LIFT" means "Living In Faith Together"
- b) "Grace" means Grace Evangelical Lutheran Church of Fremont, Ohio
- c) "St. John's" means St. John's Evangelical Lutheran Church of Fremont, Ohio
- d) "Faith" means Faith Evangelical Lutheran Church of Fremont, Ohio
- e) "St. Mark" means St. Mark Evangelical Lutheran Church of Fremont, Ohio
- f) "Trinity" means Trinity Evangelical Lutheran Church of Kingsway, Ohio
- g) "Emmanuel" means Emmanuel Lutheran Church of Hessville, Ohio
- h) "Ministry Teams" means the members of the congregations of LIFT who regularly help to plan and carry out mission and/or mission support activities in a particular area
- i) "ELCA" means the Evangelical Lutheran Church in America or its successor body
- j) "NWOS" means the Northwest Ohio Synod of the ELCA, or its successor body
- Worshiping Community" means a group of persons regularly gathered around word and sacrament
- I) "LIFT Parish" means the sum of all those congregations and worshiping communities that have approved these Articles of Agreement pursuant according to its terms
- m) "LIFT Parish Board" "LIFT Board" or "Board" shall mean the managing Council responsible for managing the cooperative ministry of the LIFT Parish under this agreement.
- n) "Code" means the Internal Revenue Code of 1986, as amended ("Code").

#### 2) Name of Organization

The organization shall be known as "Lift Parish, LLC," but may be referred to internally as "LIFT Cooperative Ministry Parish" or "LIFT Parish".

#### 3) Purpose

The purpose of the organization is to further Code Sec. 501(c)(3) exempt religious, charitable, and educational purposes allowable under Code Sec. 501(c)(3) of its members by sharing resources and opportunities for mission and ministry, to grow disciples of Jesus Christ, to discern a shared vision for God's mission in the Greater Fremont area, and to share the good news of God's love in Jesus Christ with our community and with the world.

#### 4) Membership Eligibility & Forfeiture

- (a) <u>Eligibility</u>. Any member organization must be organized and operated under Code Sec. 501(c)(3) exclusively for religious, charitable, or educational purposes, or be an agency or instrumentality of the United States, any State or political subdivision thereof.
- (b) <u>Forfeiture</u>. Should a member cease to be organized and operated under Code Sec. 501(c)(3) exclusively for religious, charitable, or educational purposes then it shall forfeit

its membership.

#### 5) Membership Transfer Prohibition

No member may transfer its membership without the prior written consent of the other members; provided always, any transferee shall be organized and operated under Code Sec. 501(c)(3) exclusively for religious, charitable, or educational purposes, or be an agency or instrumentality of the United States, any State or political subdivision thereof.

#### 6) Enforcement by Members

The members shall expeditiously and vigorously enforce all of their rights in the organization and pursue all legal and equitable remedies to protect their interests in the organization.

#### 7) Prohibitions

- (a) No part of the earnings of the organization shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for goods and services rendered.
- (b) No substantial part of the activities of the organization may consist of carrying on propaganda or attempting to influence legislation.
- (c) The organization shall not participate in, or otherwise intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

#### 8) Transfer of Assets - Fair Market Value Required

- (a) <u>Transfer of Assets to Non-Member</u>. Any asset of the organization may only be transferred (directly or indirectly) for fair market value to any non-member organization that is not a Code Sec. 501(c)(3) organization or an agency or instrumentality of the United States, any State or political subdivision thereof.
- (b) <u>Transfer to Former Member</u>. Any asset of the organization may only be transferred (directly or indirectly) for fair market value to a former member organization that ceases to be a Code Sec. 501(c)(3) organization or an agency or instrumentality of the United States, any State or political subdivision thereof.

#### 9) Guidelines

In pursuit of this purpose, we will:

- (a) proclaim Jesus as Lord in word and deed
- (b) be guided by scripture and led by the Holy Spirit
- (c) be open to God's work in and around us
- (d) love one another, respect one another and pray for one another
- (e) pray and worship together regularly
- (f) speak the truth in love and listen to one another in love
- (g) be flexible and open to change
- (h) respect and honor the gifts of each congregation and the gifts and ministries of the parish as a whole

(i) maintain a cooperative relationship with the overall area mission strategy of the Eastern Conference and Northwest Ohio Synod of the ELCA.

#### 10) Parish Administration / Management

- a) <u>LIFT Parish Board</u>. The LIFT Cooperative Ministry Parish shall be managed by the LIFT Parish Board. The voting members of the LIFT Parish Board shall include the following:
  - (1) Two lay members each from congregations participating as full members of the LIFT Parish.
  - (2) One lay member <u>total</u> from among worshipping communities not part of a congregation.
  - (3) All of the pastors of LIFT and LIFT full member congregations, ex officio.
- b) In general, each lay member shall serve for a two-year term. However, at the initiation of this agreement, half the lay members of the LIFT Parish Board shall be elected to a two-year term and the other half to a three-year term. Thereafter, each lay LIFT Board member will be selected annually, to a two-year term.
- c) <u>Term Limit</u>. Members may serve consecutive terms, except that no one elected under section a) (1) shall serve more than 3 consecutive terms.
- d) Associate Membership. Upon request, the LIFT Board may designate a congregation or worshiping community cooperating in any LIFT ministries as an Associate Member of the LIFT Parish. When so designated, a lay representative and pastor of the Associate Member may attend Board meetings and have voice but not vote. Where funds are exchanged; or joint staff hired or called, the terms of cooperation will be described in a written cooperative ministry plan. LIFT congregations may continue to participate in LIFT ministries as an associate member of the Parish even if the congregation does not vote to become a LIFT Parish Member under the terms of Section 7.
- (e) Quorum. A quorum of the LIFT Board is a majority of LIFT Board voting members.
- (f) <u>Responsibilities</u>. The LIFT Parish Boardwill:
  - (i) oversee and provide for the administration of this parish to enable it to fulfill its functions and perform its mission,
  - (ii) promote peace and goodwill and, as differences and conflicts arise, endeavor to foster mutual understanding,
  - (iii) have general oversight of the life and activities of this parish,
  - (iv) lead this parish by stating its mission, doing long-range planning, setting goals and priorities, and evaluating its activities in light of its mission and goals,
  - (v) provide for incorporation as a nonprofit Limited Liability Corporation,
- (g) <u>Frequency</u>. The LIFT Parish board will meet at least quarterly.
- (h) Officers
  - The LIFT Board will elect a vice-chairperson annually to serve one year as vice-chair and one year as chair.
  - (ii) The LIFT Board will elect a secretary annually.
  - (iii) The treasurer shall be elected by a 2/3 majority of the LIFT board. The treasurer shall

serve a two-year term. The treasurer need not be a member of the LIFT board, and if not a member, shall have voice but not vote in the meetings of the LIFT board.

- (iv) The Treasurer shall:
  - (A) prepare and submit regular financial reports to the LIFT Parish Board.
  - (B) assist in the preparation of the annual budget of the parish.
  - (C) keep the bank accounts for the parish.
  - (D) keep the books of account of the parish.
  - (E) disburse all funds on proper orders as designated by the LIFT Board.
  - (F) take the necessary steps to protect this LIFT Board and its members from liability.
- (v) An independent audit of the books of the parish shall be conducted annually.

#### 11) Authority

- a) <u>Parish</u>. The authority of the LIFT Parish rests with the LIFT Parish Board, who is responsible to develop parish ministry plans and strive to implement those plans. The LIFT Board has authority to set the compensation package for parish staff in accordance with the compensation guidelines of the Northwest Ohio Synod of the ELCA.
- b) <u>Congregations</u>. Nothing in this agreement shall diminish or undermine the identity and authority of a participating congregation, including the authority to make its own decisions, hire its own staff, call its own pastor or make other decisions regarding their individual congregations.
- c) <u>Worshiping Communities not part of Congregations</u>. LIFT Worshiping Communities which are not a part of any LIFT congregation shall have the autonomy and authority and representation as defined in a written ministry plan approved by the LIFT Board, as it may be revised from time to time.

#### 12) Entry

A 2/3 majority vote of the members present and voting at a congregational meeting called in accordance with that congregation's constitution shall be required for that congregation to adopt these Agreement and enter the LIFT Parish. After the formation of the LIFT Parish, a majority vote of the members of the LIFT Parish Board shall be required for a church to enter the LIFT Parish, in consultation with the synod staff.

#### OR

A majority vote to adopt this agreement according to the polity of the church requesting membership in the LIFT Parish must be obtained. A majority vote of the members of the LIFT Parish Board shall be required for a church to enter the LIFT Parish, in consultation with the synod staff.

#### 13) Effective Date

The organization's secretary shall certify the effective date of this agreement.

#### 14) Responsibilities

a) <u>Pastoral Responsibilities</u>. In keeping with the responsibilities of pastors as defined in the constitutions of the ELCA and the Letter of Call to Ordained Ministry, the pastors of this parish shall:

- Lead worship, including preaching, administration of the sacraments, marriages and funerals. Pastors may train and supervise lay assistants to assist them in these activities. Pastors shall rotate in their worship leadership in each of the congregations of the parish,
- ii) Provide for and coordinate pastoral care, including visitation of and care for the sick, the homebound, the grieving, inactive and prospective members, and members of the broader community as appropriate,
- iii) Engage in continuing education and professional development and share insights learned within the parish,
- iv) Nurture relationships with and between the members of the parish,
- v) Equip all the baptized to share in ministry and mission,
- vi) Provide for Christian education in order to foster spiritual growth and discipleship, including confirmation/catechism classes, new member classes, regular Bible study, and teaching and modeling spiritual disciplines (prayer, tithing, fasting, meditation, etc.),
- vii) Ensure that the records and rosters of the congregations and Parish are maintained annually.
- b) <u>Congregational Responsibilities</u>. The congregations of this parish shall:
  - i) Practice wide-open and active hospitality, inviting others to participate in the life of the parish and welcoming guests in the name of Christ.
  - ii) Nurture relationships with one another and with the community at large.
  - iii) Engage in community outreach, including feeding the hungry, sheltering the homeless, clothing the naked, visiting the sick and imprisoned, and caring for the least, the last, the lost and the lonely in the spirit of Matthew 25:31-46.
  - iv) Participate actively in the shared ministries of the parish and actively seek opportunities to share ministry with each other.
  - Engage in self-study to identify areas of strength and opportunities for growth.
  - vi) Actively seek to communicate to their members and to other congregations within the parish about their mission and ministry.
  - vii) Commit to welcoming and loving treatment of rostered leaders and their families and honor the ministries of all leaders within the parish.
  - viii) Seek to grow faithfully in their Mission Support to the Northwest Ohio Synod and the ministries of the broader church.
  - ix) Be good stewards of and make faithful use of buildings, grounds and other congregational assets.
  - x) Be accountable to one another in love as fellow workers in Christ.

- c) <u>Responsibilities of All Baptized Members</u>. Governed by a spirit of love, mercy and compassion in our life together, every baptized member will be encouraged to:
  - (i) Attend worship regularly
  - (ii) Participate actively in the ministries of the parish and congregations
  - (iii) Participate in the Ministry Teams of the Lift Parish

(with the teams providing reports to the board)

- A. Children, Youth and Family
- B. Caring for Members and the Community
- C. Worship and Music
- D. Evangelism and Outreach
- E. Hospitality and Fellowship
- F. Property Support
- G. Finance, Administration and Leadership Support
- H. Stewardship
- (iv) Participate in the Prayer and Discipleship groups of the Lift Parish
  - A. Faith Engagement
  - B. Equipping
  - C. Welcoming Diversity
  - D. Justice for our Neighbors
  - E. Sustainable Connections
- (v) Grow in faith through:
  - A. daily prayer
  - B. regular study of Scripture
  - C. service in the congregations, community and wider world
  - D. generous giving and the intentional practice of Christian discipleship
  - E. be open-minded and willing to change

As followers of Jesus Christ, we will commit to love one another, serve one another, listen to one another, be honest with one another, care for one another, trust one another, challenge one another, encourage one another, hold one another accountable and receive every person as we would receive Jesus Christ.

#### 15) Call Process

The call of a pastor to serve the parish shall be under the guidance of the Office of the Bishop of the Northwest Ohio Synod. There shall be a call committee for the parish, consisting of the senior pastors of each participating congregation and at least one lay member from each worshiping community, with no less than six nor more than twelve total members. The members of the call committee shall be elected by the respective congregation councils. A 2/3 majority vote of those present and voting at a combined Parish meeting called in accordance with each congregation's constitution for a congregational meeting shall be necessary for approval of the pastoral candidate. If the call is approved, the congregations authorize the LIFT Parish Board to issue the call. Mutual Ministry Committee

There shall be a Mutual Ministry Committee consisting of at least one member from each worshiping community in the parish, and no fewer than six nor more than 10 members. The members of the committee shall be selected in consultation between the rostered leaders and LIFT Board. The Mutual Ministry Committee will be affirmed by the LIFT Parish Board. The Mutual Ministry Committee shall facilitate communication and assist the rostered leaders of the parish and congregations in reviewing the ministry goals of the parish and the respective

congregations.

#### 16) Shared Expenses

- The parish may share staff expenses as appropriate, including the compensation and benefits for:
  - i) rostered leaders, if applicable
  - ii) shared administrative staff, if applicable
  - iii) shared programmatic staff, if applicable
  - iv) shared musicians, if applicable
  - v) shared music director, if applicable
- b) The parish will seek, as much as possible, to share expenses related to programming of mission and ministry, such as, but not limited to:
  - i) office equipment and supplies
  - ii) software and licensing
  - iii) confirmation instruction
  - iv) youth ministry
  - v) music
  - vi) special events
  - vii) vehicles
  - viii) internet presence
  - ix) property management and insurance, as applicable
  - x) preschool

#### 17) Pastor's Compensation

Compensation of pastors and rostered leaders serving the parish will be consistent with the Northwest Ohio Synod's Compensation Guidelines.

#### 18) Finances

- (a) There shall be a parish treasury out of which the parish treasurer shall pay all expenses. An annual audit will be conducted independently and shared with the parish board and all congregations of the parish.
- (b) For the 2016 calendar year, the participating congregations will commit to contribute financially to the parish in specified amounts as determined by a budget committee, comprising at least the senior pastors and treasurers of each participating congregation, and presented at the congregation's annual meeting together with a description of the use of those funds.
- 19) Congregational contributions for future years will be established through annual Parish Congregational Budgets adopted by December 1 for the subsequent calendar year. Special Meetings

Special meetings of the parish may be called by the LIFT Board chairperson in consultation with the individual congregational council presidents and the pastors, or by any two board members.

#### 20) Review and Changes

- (a) Method of Change. The participating congregations agree to an annual review of this agreement to be conducted in consultation with the senior pastors, the councils of the participating congregations and the Office of Bishop of the Northwest Ohio Synod. Changes or modifications to these Articles of Agreement may be made by a 2/3 vote of members of each congregation present and voting at congregational meetings or a parishwide meeting, called in accordance with congregational constitutions. All proposals for changes shall be recommended by the parish board to each congregation council for congregational vote.
- (b) <u>Limitation on Change</u>. Any amendment to this agreement, or other governing document of the organization, shall comply with the rules, requirements, and limitations of Section 501(c)(3) of the Code.

#### 21) Terms of Dissolution/Termination

After consultation with the Office of the Bishop, termination of this agreement and dissolution of the organization by a congregation shall be by a 2/3 majority vote of the members of the congregation present and voting at a congregational meeting called in accordance with that congregation's constitution. Written notice will be given to the LIFT Board by July 1 of a congregation's intention to withdraw from the parish for the following calendar year.

#### 22) Distribution of Assets Upon Dissolution/Termination

Upon termination and dissolution of the organization, all the assets of the organization shall be distributed either to: The Northwest Ohio Synod of the Evangelical Lutheran Church in America, or its successor, provided such organization is then organized and operated exclusively for charitable, educational, or religious purposes under Section 501(c)(3) of the Code, or (ii) any other organization(s) which then qualifies as a exempt organizations under Section 501(c)(3) of the Code.

#### 23) Merger / Conversion

The organization is prohibited from merging with any organization who is not exempt under Section 501(c)(3) of the Code. Likewise, should the organization ever convert to another form of entity, such conversion is limited to an entity which qualifies as an exempt organization under Section 501(c)(3) of the Code.

#### 24) Specific Arrangements/Other

Worship times shall be established in consultation between the congregations of the parish and the LIFT Board.

#### 25) Incorporation

The LIFT Parish shall be incorporated under the laws of Ohio as a nonprofit limited liability corporation (LLC). This LIFT Parish, LLC shall be the congregation of record for any individuals within LIFT not otherwise members of any congregation of LIFT.

#### 26) Merger

Merger of a participating congregation with this LIFT Parish, LLC shall require approval by the LIFT Board and each LIFT member congregation council.

#### **LIFT Parish By Laws**

#### **Delegation of Authority**

The Board hereby delegates to the Executive Committee (comprising the Chair, Vice-Chair, Treasurer, Secretary and LIFT pastors) the taking of executive action on behalf of the Company, provided that:

- 1) the Board is notified of significant actions in advance
- 2) no board member requests full Board review.

The Board hereby delegates to the Finance and Administration mission support team, the taking of all routine administrative actions on behalf of the Company, provided the Executive Committee is kept informed and no member of that Executive Committee or the Board requests full review.

The Board hereby delegates to each Mission Team the taking of all actions within their area of responsibility, provided they keep the Executive Committee informed and coordinate and cooperate with the other mission teams that may be affected. Any Board member or alternate can request Board review and decision at any time, for any issue, where that person believes there may be a significant difference of opinion about the right decision, or where further consideration would be necessary or useful, and the request is made in writing to any member of the Executive Committee.
